

### Why the "HOW" of Physical Therapy Practice Should Matter to Everyone

My earliest recollection of medical care was as a child in a children's hospital. I was put in the isolation ward at the age of four because I had a severe case of whooping cough and required oxygen and monitoring. I remember the gowned and masked members of the medical team coming in with their friendly eyes and their happy voices, but I had no idea what they looked like until I watched them

change through the window of the gown room.



My parents trusted the medical team, but, more than that, they trusted the system that was put in place to make sure that rules were followed to keep me safe and that each member of the team was following their training and their responsibilities. There was a shared understanding that patient safety and outcomes were protected through a standardized way of evaluating the aptitude of the professionals and addressing any failures or lapses in their conduct.

This is so significantly engrained in our daily operations, we may not regularly consider what it means in our everyday life. Our root canals are not completed by dentists who did not pass their national exams. Our blood is not drawn by nurses who have not kept up on their competencies. Our surgeries are not completed by physicians who have been arrested without notifying the Board.

While concerns about the safety of your experiences during routine interactions with healthcare professionals likely isn't at the front of your mind, it doesn't mean that it isn't necessary to maintain regulations. In fact, it's a very good thing if you are not actively concerned with every medical appointment because it means—for the most part—you have experienced a system you can trust.

With changes in healthcare policy and more Americans experiencing extended recovery from viruses and chronic conditions, more people are using physical therapy and rehabilitation services to try to resume full function of their bodies and avoid severe disabilities. The field of physical therapy is also unique in its multiple settings and specialty areas which may have different needs. PTBC exists to ensure that, based on the scope of practice established by the California Legislature, the public can expect physical therapy to be delivered in a safe, consistent, equitable way to all Californians. Trust is created when a minimum standard of competency and safety is established and upheld for a profession through regulation. Certainly, all physical therapy stakeholders benefit from keeping the physical therapy workforce in California qualified and safe.

We also recognize that as healthcare shifts, so may the role of the physical therapist and physical therapist assistant in California. Some areas may be straightforward, while others may require new regulation methods. Ultimately, PTBC will continue to be responsive to the practice changes that happen in California. For example, one fast growing trend in healthcare is the use of AI for things like documentation or patient data analysis. PTBC evaluates advancements in this field as well as others to facilitate maintenance of the highest standards of consumer protection and to promote patient safety and advanced specialization competencies as they arise.

Whether you are a member of the public or a licensee, we at PTBC are here to maintain the expectations set forth by the state laws and regulations, educate the public on informed care, and guide individuals to answers about practicing in our great state of California, which has almost 40,000 active physical therapists and physical therapist assistants.

I am honored to serve and grow with our exceptional staff and meet the mandate of consumer protection for the consumers of California.

## Who is the Physical Therapy Board of California (PTBC)?

The Physical Therapy Board of California (PTBC) is a government agency within the Department of Consumer Affairs. PTBC licenses and disciplines physical therapists and physical therapist assistants. PTBC provides three principal types of consumer services: verifies education and background prior to licensure, shares information about the practice of physical therapy by physical therapists and physical therapist assistants, and investigates complaints against physical therapists and physical therapist assistants.

### **Board Meetings**

Board meetings are mandated to three board meetings a year. Typically, PTBC conducts four meetings a year in Northern and Southern California. Board meetings are usually two days long, and the public is highly encouraged to attend.

### Benefits of Hosting a Board Meeting

- Consumers in the area can be educated on the practice of physical therapy.
- Licensees in the area can attend and receive continuing competency credit while having their voices heard on topics being discussed.
- Students and applicants can attend in between classes and learn how PTBC operates and how decisions are made that affect the profession.
- Name recognition for the hosting location.

Licensees are required to provide PTBC with an email address if they have one. Email is an efficient conduit for sharing information between PTBC and its applicants and licensees. PTBC will be able to communicate regarding the status of applications, renewals, and requests for various PTBC services; provide law and regulation updates; and disseminate important PTBC news directly to each applicant and licensee. PTBC hopes this accelerated delivery and exchange of information will decrease processing times in all aspects of PTBC's programs and keep licensees apprised of laws, regulations, and PTBC

activities. Moreover, with the transition to the BreEZe system, email will be the standard method of communication. You can submit/update your email

## PROGRAM SPOTLIGHT: CALIFORNIA STATE UNIVERSITY, LONG BEACH (CSULB)



# LONG BEACH

California State University, Long Beach (CSULB) was initially accredited by the Commission on Accreditation in Physical Therapy Education (CAPTE) in 1968. For the years 2022 and 2023, CSULB, on average, had a first time licensure pass rate of 95.45% and a graduation rate of 98.45%. For the years of 2021 and 2022, CSULB had an average employment rate of 100%.

PTBC is invited every year to CSULB to provide a two-hour workshop that includes a step-by-step presentation on how to apply for licensure, PTLA, and continuing competency requirements. Staff also explain the differences between PTBC's mandate of consumer protection and other organizations, such as the California Physical Therapy Association (CPTA), that play a role in the profession of physical therapy.

After each presentation, there is a Q&A where students can ask PTBC staff anything they want to know about their road to licensure or the laws and regulations surrounding the profession. This gives the students an opportunity to gain a better understanding of the Physical Therapy Practice Act, what is needed to apply for licensure, and what happens after they are licensed.

PTBC would like to thank CSULB for continuing to invite PTBC staff back to provide this workshop. We look forward to these presentations and meeting each new cohort every year.



## HOW CAN PHYSICAL THERAPY HELP YOUR MENTAL HEALTH?


Physical therapy is often associated with recovering from injuries or managing chronic pain, but it can also play a significant role in improving mental health by addressing both the body and the mind in the following ways:

- **6. Creating Mindfulness and Focus:** Physical therapy encourages patients to focus on their movements and body alignment. This mindfulness can help shift focus away from negative thoughts and promote a more positive mindset.

## STAFF SPOTLIGHT: LICENSING EDITION

### **TERESA GUTIERREZ**

Teresa Gutierrez is one of the most experienced and knowledgeable Applications Analysts with the Licensing Services Program of the PTBC. As a long-time employee, Teresa is a staff member to whom other staff members go for accurate answers to general questions about PTBC, the application process, BreEZe usage, and more. Teresa's attention to detail and work ethic are exemplary, yet she is always good-natured, friendly, and easy to talk with.

#### Q: How long have you been with PTBC?

15 years.

#### **Q: Where did you work before PTBC?**

PTBC was my first job. I started here about a month after high school graduation.

## Q: Have you always worked in the Licensing Unit at PTBC?

No, I started as a student assistant and assisted in various units, admin, applications, and licensing.

## Q: If you were not a Licensing Analyst for PTBC, what would you be doing?

Most likely a teacher.

### Q: Walk me through your day at work.

A typical day as an Application Analyst involves processing applications for foreign-educated applicants. I begin by responding to emails and voicemails. Then I review applications for examination, review documentation for clinical service approval, and assess clinical evaluations to ensure they meet regulatory requirements before issuing a license. Each application is processed in the order it is received. Throughout the day, I also handle phone calls and emails, providing guidance and support to applicants and stakeholders.

## Q: What do you find most rewarding about what you do?

The most rewarding part is seeing applicants achieve their career goals by guiding them through the licensure process.

#### Q: What is the most difficult part of your job?

When an applicant is unable to meet the application requirements, which prevents them from receiving their license. The situation is challenging, as it impacts their career aspirations.

#### Q: What advice would you give to an applicant?

I would advise applicants to thoroughly read the application requirements to ensure they understand every detail. Also, don't hesitate to reach out to PTBC for assistance.

#### Q: What advice would you give to a licensee?

I would advise licensees to be familiar with the laws and regulations, stay up to date with the continuing education requirements, and ensure their address is updated with PTBC.

#### Q: What does consumer protection mean to you?

To me, consumer protection means diligently ensuring that applicants meet the established licensing requirements, thereby guaranteeing that consumers receive the highest quality of care.

### **ARIANA RATHBUN**

Ariana Rathbun has been an Applications Analyst with PTBC for three years. With a positive, can-do attitude, excellent communication skills, and a talent for simplifying complex information, Ariana has proven to be an asset to the Licensing Services Program. Ariana consistently demonstrates her ability to handle all aspects of her Applications Analyst position—attention to detail, application evaluation, excellent customer service—in an exemplary and efficient manner.

#### Q: How long have you been with PTBC?

I have worked at PTBC for almost three years.

#### Q: Where did you work before PTBC?

Before joining PTBC, I worked at the Department of Justice.

## Q: Have you always worked in the Licensing Unit at PTBC?

Yes, I have always worked within the Licensing Unit.

## Q: If you were not a Licensing Analyst for PTBC, what would you be doing?

If I was not a Licensing Analyst for PTBC, I would most likely further my education.

### Q: Walk me through your day at work.

On a typical day at work, I first respond to emails and update applications with any fulfilled deficiencies that were sent to me. Then, I check for exam scores and update the applications of applicants who passed their exams. Next, I check on all results for applicants who are pending fingerprinting results. I then begin to review applications. I spend at least a couple hours a day on the phone speaking with applicants. At the end of the workday, I make a list of things that need to get done the following day in order of prioritization.

## Q: What do you find most rewarding about what you do?

The most rewarding part of my job is helping applicants reach their dreams and goals of becoming Physical Therapists or Physical Therapist Assistants in California.

#### Q: What is the most difficult part of your job?

The most difficult part of my job is when I am unable to approve an applicant for licensure.

#### Q: What advice would you give to an applicant?

My best advice to give to an applicant would be to apply early and make sure that you are sending in all proper documentation to your analyst to be licensed in a timely manner. Also, please be patient with the application processing time.

#### Q: What advice would you give to a licensee?

My best advice to give a licensee would be to make sure that you are following all continuing competency requirements and that you are renewing your license on time.

#### **Q**: What does consumer protection mean to you?

As a Licensing Analyst, consumer protection means doing my due diligence in the reviewing of applications to ensure that I am only licensing qualified applicants in order to protect consumer safety.

## **ASSISTIVE PERSONNEL**


When receiving physical therapy treatment, you may encounter a variety of personnel assisting the Physical Therapist (PT) in providing treatment. Such personnel could include a Physical Therapist Assistant, a Physical Therapy Aide, a Physical Therapist Licensed Applicant or Physical Therapist Assistant Licensed Applicant, as well as a Student Physical Therapist or Student Physical Therapist Assistant completing their clinical education.

### PHYSICAL THERAPIST ASSISTANT (PTA)

A PTA is licensed by the Board to assist a PT. A PTA can provide any treatment the supervising PT or PT of Record (the PT that evaluated the patient or to whom the patient was officially transferred) has directed in the plan of care and that is within the scope of physical therapy practice so long as the PTA is deemed qualified and competent to perform the treatment. Since a PTA cannot work autonomously, the PT must be available to ensure proper supervision. A PT does not need to be at the same treatment location as the PTA; however, the PT must be immediately available for telecommunication consultation or to be at the treatment location should the need arise. A PT can supervise no more than two PTAs at any one time. While PTAs can provide most patient care as directed and supervised by a PT, there are some aspects of care PTAs cannot perform, including patient evaluations; writing discharge summaries; establishing a plan of care; performing



measurement, data collection, or care prior to the evaluation of the patient by the PT; being the sole physical therapy representative in any meeting with other healthcare professionals where the patient's plan of care is assessed or may be modified; and writing progress reports to another healthcare professional. Moreover, a PTA cannot provide patient treatment while holding a management position in the physical therapy business where the care is being provided, nor can a PTA supervise a Physical Therapy Aide performing patient-related tasks. A PTA shall document all treatment they provide to the patient.



### PHYSICAL THERAPY AIDE (AIDE)

An Aide is an unlicensed individual, at least 18 years old, who aids a licensed PT. An Aide cannot independently perform physical therapy and must always be under the continuous and immediate supervision of a PT who is in the same treatment area and readily available at all times for intervention. An Aide cannot be supervised by a PTA, PT Licensed Applicant, PTA Licensed Applicant, Student PT, or Student PTA. An Aide performing patient-related tasks may include any part of the treatment plan assigned to the Aide that is not otherwise required to be done by the PT. If treatment is provided by an Aide, the supervising PT must, at some point during the treatment day, provide direct services to the patient. While the PT is limited to only one Aide performing patient-related tasks, there is no limit to the number of Aides the PT can employ for non-patient-related tasks, such as answering phones, scheduling patients, filing and record keeping, cleaning treatment areas, providing physical support only during gait or transfer,

or any other task that can be accomplished by an unlicensed individual that is not directly related to physical therapy treatment. If a PT utilizes an Aide, the PT shall document this in the patient record. The Aide's competencies to perform the assigned patient tasks shall be documented and made available to the Board or another PT utilizing the services of the Aide upon request.

### PHYSICAL THERAPIST LICENSED APPLICANT (PTLA) OR PHYSICAL THERAPIST ASSISTANT LICENSED APPLICANT (PTALA)

New graduates who apply for licensure with the Board may practice as a PTLA or PTALA. PTLA/PTALA status allows an applicant to work as a PT or PTA under direct and immediate supervision which is in close proximity to the treatment location. To work as a PTLA or PTALA, the applicant must receive an authorization letter from the Board, and a copy of this authorization letter shall be provided to, and maintained by, the supervising PT. A PTLA or PTALA shall document all treatment provided to the patient in the patient record, and the supervising PT shall countersign these notes on the same day the treatment was provided.

### STUDENT PHYSICAL THERAPIST (SPT) OR STUDENT PHYSICAL THERAPIST ASSISTANT (SPTA)

During a period of clinical practice or observation related to educational experience involving recipients of physical therapy treatment, a person so engaged is, and shall be identified as, a "Student PT or Student PTA."

#### **REMINDERS/TAKE AWAYS**

- A PT is responsible for ALL care provided by any physical therapy assistive personnel.
- All physical therapy care providers are required to wear a nametag with their title.
- The public can verify PT and PTA license holders online at <u>www.ptbc.ca.gov</u>.
- Physical therapy assistive personnel shall not provide care without a PT first performing an evaluation and establishing a plan of care.


## LESS IS MORE

### PTBC HAS ELIMINATED THE POCKET LICENSE!

PTBC has made license verification more effective and efficient for consumers and licensees. As of July 2020, PTBC no longer issues pocket licenses upon initial licensure or renewal. Pocket licenses may not reflect a licensee's current status, as it may change within the two-year license period, and they do not display any enforcement action taken against a license. Current license status and enforcement action information is available on the California Department of Consumer Affairs (DCA) License Search, an online license verification system. Consumers, employers, or any interested party can access license information online, 24 hours a day, seven days a week. You can access the DCA License Search system on the homepage of the PTBC **website**.

## SUBSTANCE ABUSE REHABILITATION HOTLINE

Physical therapists (PTs) and physical therapist assistants (PTAs) are not immune from the diseases of chemical dependency. Experts estimate that at least 10% of the general population will have a problem with alcohol or drugs at some point in their lives. Health care professionals, including PTs and PTAs, may be particularly susceptible to substance abuse problems due to the stresses of working in a health care environment and due to an increased opportunity to obtain controlled substances.

Many PTs and PTAs who experience problems with chemical dependency can find the help and support they need without involvement from PTBC.

If chemical dependency problems are left untreated, they may eventually jeopardize patient health and safety. They can also threaten the life of the person afflicted. In these cases, it becomes imperative that individuals who detect a chemical dependency health problem in a PT or PTA take action. Without intervention, diseases have predictable courses and outcomes. The PTBC's Substance Abuse Rehabilitation Program aims to identify symptoms, intervene, and change the outcomes.

The Substance Abuse Rehabilitation Program also provides an effective alternative to the traditional disciplinary process.

## **Glossary of Terms**

Accusations: Charges filed against a licensee alleging violation(s) of the Physical Therapy Practice Act.

**Interim Suspension Order**: An order issued upon petition, suspending a licensee from all or specified part of their practice of, or assisting in the provision of, physical therapy.

**Petition to Revoke Probation**: Charges filed against a probationer seeking revocation of their physical therapy or physical therapy assistant license based upon violation(s) of probation.

**Probationary License**: Where good cause exists to deny a license, the licensing agency has the option to issue a conditional license subject to probationary terms and conditions.

**Public Letter of Reprimand**: In lieu of filing a formal accusation, the Board may, pursuant to B & P Code section 2660.3, upon stipulation or agreement by the licensee, issue a public letter of reprimand. If the licensee does not agree to the issuance of the letter, the Board shall not issue the letter and may proceed to file a formal accusation. A public letter of reprimand is considered disciplinary action.

**Statement of Issues Filed**: Charges filed against an applicant due to alleged violation(s) of the Physical Therapy Practice Act. If found to be true, the charges may result in discipline.

**Surrender of License**: The licensee surrenders their license to the Board, subject to acceptance of the surrendered license by the Board, and the licensee is prohibited from engaging in the practice, or assisting in the provision, of physical therapy.

Stipulated Decision: Negotiated settlements waiving court appeals.



## ADMINISTRATIVE ACTIONS——CITATIONS



A Citation and Fine is an administrative action by which PTBC may address relatively minor violations of the Physical Therapy Practice Act that would not necessarily warrant discipline in order to protect the public. Citation and Fine Orders ARE NOT disciplinary actions but are matters of public record. Citations remain on a licensee's file for five years and are then purged. By law, payment of a fine is considered satisfactory resolution of all violations contained in the citation.
