Occupational Analysis Participation Opportunity

<u>Project:</u>

The Physical Therapy Board of California (PTBC) has entered into an agreement with the Department of Consumer Affairs' Office of Professional Examination Services to conduct an occupational analysis (OA) of the physical therapy profession. The purpose of this project is to identify the tasks and knowledge that are critical to practice so they may be used to evaluate the PTBC's licensing examinations. The assistance of licensed physical therapists and physical therapist assistants is needed to provide information on current practice.

Subject Matter Expert (SME) input is critical to each phase of the OA in that they provide the information to define the tasks performed in the practice. SMEs also define the knowledge that is necessary to perform tasks safely and competently, in compliance with standards of care.

The PTBC is **currently** recruiting licensees to serve as SMEs to participate in the OA process. As a licensed physical therapist or physical therapist assistant, the Board requests your assistance in this process. New licensees (5 years or less) are encouraged to apply as well, as your input is needed to maintain standards at entry level.

SME Participation:

The OA interviews and workshops will be conducted by **teleconference** between the end of August 2024 and beginning of April 2025.

To qualify to serve as an SME a licensee MUST have:

- 1. A current California physical therapist or physical therapist assistant license
- 2. All renewal fees paid as required.
- 3. All continuing-education requirements met.
- 4. No accusation or other legal action filed against him or her by any agency or government.
- 5. No admonishments or disciplinary actions.
